

Introduction by Shafik Gabr

The Shafik Gabr Foundations, both in Egypt and the US, are dedicated to creating opportunities for citizens to enhance their own futures by providing them with the tools to maximize their potential.

Although technology has revolutionized the way we all are able to interact with one another, placing a wealth of information at our fingertips and connecting us to one another more rapidly than ever before, the notion that this increases our knowledge of each other could not be further from the truth. Mass media and social media all too often serve as a filter that inevitably shapes our perceptions, with the most sensational, polarizing and disruptive voices garnering the most headlines. The medium truly has become the message.



The "East-West: The Art of Dialogue" initiative sprung from the conviction that non-governmental institutions can affect real change and that each citizen must play a role in building bridges towards sustainable peace and cross-cultural understanding. The initiative's flagship program, the Gabr Fellowship, focuses on providing opportunities for tomorrow's leaders to create a meaningful impact on the lives of others within our increasingly globalized community. We are not only creating space for young professionals to break through the digital shackles and engage directly with one another face to face, we are also creating a platform for them to identify issues, brainstorm ideas and come up with real-world solutions.

This year's Fellows (20 young professionals from Egypt, US and UK) have "lived together" for 2 weeks in Egypt and 2 weeks in the United States and experienced first-hand the unique, and sometimes most challenging, aspects of both eastern and western cultures. They identify issues, brainstorm ideas, assess needs and potential, and implement innovative, real-world solutions. These Fellows are accomplishing what national governments and international corporations have repeatedly failed to do—they are closing the divide between regions, creating workable, sustainable model programs, improving their societies and mitigating the erosion of public understanding.

The Gabr Fellowship has engaged some of the most accomplished and creative minds of this generation. As politicians on both sides of the Atlantic struggle to deal with conflict, terror, new realities at home and on the global stage, these Fellows are able to explore options unrestrained by political protocols or partisan priorities. They are melding their skills and experience with new visions and pioneering solutions that utilize the most innovative technologies, as well as the most basic element of success - human interaction. Through their participation and their projects, these Fellows are sowing the seeds of community and cooperation that promise to change our worldview, and our economic, social and political trajectory toward a positive future.

The Initiative

The mission of the Shafik Gabr Foundation's initiative, "East-West: The Art of Dialogue" is to promote greater mutual understanding by building bridges between the people of the Arab world and the West, particularly with the U.S., by instigating dialogue and the exchange of ideas between these two cultures. Established in 2012, in response to the increasing tensions building between the East and West, the Foundation sponsors and fosters exchanges between emerging leaders from both cultures in the fields of arts, science, law, media and entrepreneurship – both business and social.

The "East-West: The Art of Dialogue" initiative is a dynamic exchange program designed to connect and build constructive relationships between future leaders from the Arab world and the West. Its flagship program, which has come to be known as 'The Gabr Fellowship', works towards the vital goal of building on the aforementioned ties between nations through cross-cultural dialogue and the development and execution of collaborative projects, which are the result of the combined creative visions of the Fellowship's carefully selected participants.

Each year, the Fellowship consists of 20-24 Fellows, approximately 10 Americans and 10 Egyptians, with an equal distribution of men and women. The Fellowship featured its first participant from the UK in 2015 and will continue to expand to include additional nationalities in the future. Program participants spend two weeks in Egypt, followed by a further two weeks in the U.S., building enduring connections through hands-on activities, rigorous discussions, web-based interaction and most importantly, their own collaborative action projects.

Over the past years, American and Egyptian Fellows have developed collaborative projects where they can leverage their experience and develop impactful initiatives. They share their experiences of the exchange with their peers, colleagues and societies.

The exchanges do more than introduce the Fellows to new societies. They alter the very perceptions that have been fabricated by decades, even centuries, of misinformation. They provide the opportunity for frank discussions about the issues impacting both regions and create alliances between leaders of the next generation.

The Gabr Fellows have acquired a greater understanding of both Egypt and the United States and the challenges faced by both communities. Having served as cultural and linguistic ambassadors to one another, they return home to play the role of diplomat, introducing Egyptians and Americans to a people, a culture and a future never before explored in this way. Together, through their cooperation and their projects, they are creating the legacy of 'The Gabr Fellowship': an international cohort dedicated to pursuing cooperative, collective solutions to their regions' most pressing issues.

The Foundations




The Mohamed Shafik Gabr Foundation for Social Development (Egypt)

The Fellows work jointly together to leverage their experience and launch projects that impact their peers and communities. The Foundation works in partnership with other charitable organizations, corporations and individuals to renew and strengthen ties that have bound together Eastern and Western nations over many centuries. In the United States, the Foundation also supports epilepsy research, children with cerebral palsy, educational sponsorships and other special projects.

Because Baseball: Diamond Diplomacy

Team: Kemp Gouldin, Muhammad Nagi

The Challenge

The field (or court) of play is an arena where life's greater lessons are taught - a place where young girls and boys learn teamwork, respect, sportsmanship; a place to thrill in success, a place to pick oneself up from failure. And while each sport has particular merits, baseball's unique framework celebrates the individual (the batter, the base stealer, the fielder's diving catch) while extolling actions for the benefit of the collective team (the sacrifice bunt, the double play). The challenge will be to create a new league (indeed introduce a new sport) in Egypt that will give young people an opportunity to compete, explore life lessons and grow as people. And, a sport is a universal language, it will serve a bridge across cultures between Egypt and the United States.



Project Overview

We will bring baseball to Egypt, founding the first Little League in Cairo with a handful of teams. Such a league should encourage Egyptian and expat children of all backgrounds to play together, finding a common purpose and learning to recognize common humanity in the midst of a current geopolitical climate that thrives on demarcation (i.e. creation of the other).

To build buzz and demand in Egypt, we will begin with baseball clubs at the university level. Ideally, participants in these student clubs will then become coaches in the Cairo Little League. But their role will be so much greater than merely "coaches" – they will be mentors and role models to their young players, able to teach valuable life lessons in the context of sport.

To kick off the Cairo League's inaugural season, select American coaches and umpires will travel to Egypt to teach the game to their Egyptian counterparts; and clinics will be conducted to train the local adult and children participants.

In subsequent seasons, as the league matures and grows (participation increases), additional groundbreaking exchange opportunities will result:

- 1. Egyptian coaches will visit the US as coaching fellows
- 2. US Little League teams will travel to Egypt to play their Egyptian counterparts
- 3. Egyptian teams will journey to the US to play against American teams

In each of the above exchange scenarios international diplomacy will be learned and enacted on the baseball diamond. Diamond diplomacy indeed!

The Goal

The goals are both simple and powerful:

- 1. Create a new activity for kids to engage in
- 2. Build mentorship opportunities for Cairo-area university students to connect with Cairo youth
- 3. Allow for cross-cultural understanding through the vehicle of sport

Population Served

- Baseball Clubs: Students at university education
- Youth League: Boys and girls aged 8-12 years living in Cairo

Project Milestones

- Phase 1: Founding of university baseball "clubs" (student organizations) at select Cairo universities
- Phase 2: Founding of Cairo youth baseball league
- **Phase 3:** Travel of US Coaches and umpires to Cairo for weeklong clinic with youth league coaches, university students and youth participants
- Phase 4: First pitch of the inaugural season
- **Phase 5:** During the second season, there will be a number of additional exchange opportunities between Egyptian and US youth baseball teams

Expected Outcome

While the league will be small during the inaugural season, the plan is to rapidly expand with each season to meet a growing demand among Egyptian youth to take part in this groundbreaking venture...with each passing year, the league footprint will grow, so will its overall impact on youth culture.

How the Project Contributes to the Foundation Mission

Because Baseball ultimately seeks to use the sport of baseball as a vehicle for diplomacy, setting up opportunities for youth players (as well as their adult coaches) from Egypt and the US to learn about each other's culture through various team exchanges.

The Challenge

Western mainstream media outlets have a bias for telling sensational stories that focus on negative events and often fail to cover success stories coming out of Egypt. The 24-hour news cycle has gained wide criticism from American leaders for their Twitter-fed approach for making everything appear to be a crisis while neglecting the stories of entrepreneurial innovative, cultural, and burgeoning businesses.



Simultaneously, many American news agencies fail to cover events that can be characterized as generally positive, instead preferring to create a sense of dread and fear among their viewers. The voices of journalists in Egypt rarely penetrate the Western mainstream media with success stories.

Additionally, these fear-inducing media outlets disproportionately cover negative experiences of women, or leave women out of the discourse altogether. With vast majorities of males in leadership positions and acting as decision makers in professional media outlets, the experiences of women are left to be defined by the males writing, editing, and producing the stories. While women are actively and positively participating in civic life, starting businesses, and leading cultural innovations both in Egypt and the United States, these stories are seldom told to the average consumer of media.

In summary, consumers of the media, both in the United States and Egypt, are relegated to an incomplete, sensationalist, and male-dominated perspective. These same consumers, however, rely on the media to formulate their global opinions and actions as civically-engaged citizens.

Project Overview

Inspired by powerful Egyptian and American female leaders, Cleopatra to Coretta is an international exchange program supporting the dialogue of female global journalists to build relationships and promote hero narratives of women making an impact in their community.

Cleopatra valued knowledge and female intellect above all else. Fascinated with literature and languages, she rose to power as the last of the great pharaohs in Egypt. Coretta Scott King, an American activist, writer, and champion of the civil rights movement, is best known as the wife of Martin Luther King, Jr.. Cleopatra and Coretta, who were influential and powerful women, are rarely credited. These two leaders are a mere sampling of the inspiring women that are blazing trails and challenging social norms each day.

Cleopatra to Coretta aims to bridge the gap between the East and the West, to identify and mentor emerging women leaders in the field of journalism, and to create new networks of engagement for aspiring female professionals. The project seeks to fund three female Egyptian journalists and three female American journalists who will participate in a person to person exchange program.

The participants will live and work together in both the United States and Egypt, participating in job shadowing, classes with university students, and guided discussions with industry professionals. Participants in Cleopatra to Coretta will develop media projects to profile strong female leaders in a variety of professional fields.

Project Goal

Three specific and measurable goals have been identified through this project:

- Women's Empowerment: We seek to foster women's professional development that creates a community of peer support and promote underrepresented voices.
- Positive Narratives in the Media: We seek to create shareable and accessible information online utilizing existing journalist networks and social media while highlighting success narratives of women.
- East-West Dialogue through peer-to-peer relationships: We seek to build lasting relationships
 and understanding through international exchange and develop opportunities for mentorship for
 emerging leaders.

Population Served

Female journalists in both Egypt and the United States will be the main population served in this project. By leveraging each participant's network, Cleopatra to Coretta will potentially reach and impact millions of viewers in the United States and Egypt as well as the greater Western and MENA region.

Project Milestones

- **Phase 1:** Three journalists from Egypt and three journalists from the United States will be selected to participate in the program.
- Phase 2: Participants will be engaged in a facilitated online (email, chat, forum, Skype) conversation with each other about their communities and their work.
- **Phase 3:** Participants will meet for a 3-day team building retreat in Egypt.
- **Phase 4:** Participants will travel to Egypt and the United States to meet with counterparts in their home communities to collaborate on stories for publication.
- Phase 5: Participants will create 18 special interest stories about the United States and Egypt that will be published across 3 news outlets in each country. One project report will be published in website format on CleopatratoCoretta.org, which will contains all 18 stories.

Expected Outcome

Each journalist will be responsible for creating content in their specific field of media about their experience. Participating journalists will use the platform of their professional expertise and their own media networks to develop and promote success stories and highlight cultural activities, particularly those involving and led by women.

Three journalists from two countries will immerse themselves in each others' communities to engage in job shadowing, professional development and East-West dialogue.

By the end of the 6-month project, Egyptian and American journalists will have formed new relationships, and will have collaborated on stories which focus on generally positive events in each others' communities. The American journalists will publish stories about activities in the Egyptian communities, while the Egyptian journalists will publish stories about activities in the American communities.

How the Project Contributes to the Foundation Mission

The Shafik Gabr Foundation believes that each citizen must play a role in building bridges to peace and improvement of people's lives. Cleopatra to Coretta facilitates an opportunity for citizens from both the United States and Egypt to directly build bridges by working together, forming personal and professional relationships, and proactively sharing their intercultural experiences through the media. Tantamount to the Shafik Gabr Foundation's mission, Cleopatra to Coretta is committed to fostering a voice for women to share their experiences with a global platform, based primarily in first-hand cross-cultural experiences. Furthermore, the outcomes of this action project can reach a broader global audience through sharable, digital media and the hero-narratives that are developed.

Cooking Up Cultures

The Challenge

Cooking Up Arabic is a vital but missing piece of Cooking Up Cultures programming. Egypt is the leading Arabic speaking country with the strongest positive economic ties to the United States. Egypt needs to be represented in the Cooking Up Arabic programming to help demystify and personify one of the most important Arabic speaking cultures. Likewise, the English language and American culture needs to be showcased in Egypt as a positive relationship to foster U.S. - Egypt relations.



Project Overview

Cooking Up Cultures (CUC) is a non-profit organization established in 2010 which provides dynamic cooking experiences that explore languages and cultures for those with an international curiosity. The copyrighted method of CUC blends language + cooking + culture all in one experience, ensuring participants are better neighbors than before. The goal of CUC is to reduce the cultural barriers that exist between communities and we believe using food as the universal expression of a culture is the way to accomplish this goal. Languages currently offered by CUC include: English, Spanish, French and Chinese (Mandarin). It is with high priority that Cooking Up Arabic launch out of the CUC programming. The implementation of this mission will occur in Egypt and the U.S. through these programs:

- In-Person classes. Arabic & English classes are taught at contracted facilities like school cafeterias, churches and Ramadam tents. The latter are facilitated as cooking dinner parties for up to 10 friends.
- 2) Curricula licenses. Cooking Up Arabic (CUA) and Cooking Up English (CUE) curricula will be available to schools, nonprofits and faith groups looking to add hands-on activities for language programs already operating in their facilities. This curricula is offered to accommodate all language proficiency levels in one class.
- 3) Online lessons. Our curricula is adapted for in home use on iOS, Windows and Android devices. Self-pace features include: proficiency level options (beginner, intermediate and advanced), audio and video content. Ideal for families, travelers, date nights, book clubs and foodies.

Project Goals

By September 2016, conservatively:

In-Person Classes

Reach 120 people through Cookovers in the U.S. and Egypt and 46 people through the contracted classes.

Curricula Licenses

Provide Cooking Up English licenses to 2 Egyptian schools, nonprofits or faith groups and Cooking Up Arabic licenses to 2 schools, nonprofits and faith groups in the U.S.

Online Lessons

Reach 500 users of Cooking Up Arabic online lessons.

Population Served

In-Person Classes. Contracted classes are paid for by schools who recruit participants such as families, parents, and youth aged 9-16 years old to participate. Cookover participants are provided to individuals with a curiosity in international matters, often self-described as "global citizens". Cookover hosts pay for these experiences.

Curricula Licenses. Cooking Up English and Cooking Up Arabic curricula licenses are provided to schools, faith groups and non-profits at a low cost that already deliver language acquisition programming in some capacity and are looking to incorporate hands-on activities to strengthen the language retention of their students.

Online Lessons. The users of the online lessons are: foodies, home cooks, home-school families, travelers, aspiring travelers, language students, and social groups. Online lessons will be accessible as subscription or pay-as-you-go fee structures.

Project Milestones

- Deliver first Cooking Up Arabic Cookover
- · Beta test of all CUC Online Lessons
- Conduct Cooking Up Arabic and Cooking Up English contracted classes with Austin Independent School District
- Document and film the Cookover Tour for the official launch of CUC Online Lessons
- Official launch of all CUC Online Lessons
- Provide Cooking Up English [American] license to Al Azhar, in Egypt, and train instructors
- Offer Cooking Up English [American] curricula license to other Egyptian schools, nonprofits and faith groups

Expected Outcome

Historical data of CUC suggests participants in all programming will experience an improved understanding of the Egyptian and American cultures and increased confidence speaking the respective languages. We believe by cooking culturally significant recipes together and explaining why a particular recipe is important, we can create a personal connection for individuals who may previously have felt fear or anxiety related to that culture.

How the Project Contributes to the Foundation Mission

CUC programming supports this mission of creating dialogue between the east and the west both directly and indirectly. Launching Cooking Up Arabic in the U.S. and expanding Cooking Up English to Egypt directly impacts the potential for future dialogue through teaching tangible language skills and cultural context to Americans and Egyptians. We also facilitate indirect dialogue by reaching participants who perhaps are more interested in learning about the food than they are learning about the culture or language. This indirect impact is long term and manifests over a period of time, so that at the next encounter of someone who speaks English or Arabic, participants have a basic framework to begin a conversation.

HADARA - New Perspectives, A Shafik Gabr Foundation Publication

The Challenge

In a strained interval between Egypt and the West, the respective societies are inclined to be in favor of information and analysis that support their present view. Unfortunately, these views piled up over decades of mistrust and skepticism. Further, they lack significant realities and input on how differently politics are run, decisions made, and societal givens are at one point of history. Hence, in today's globalized world, these flawed perceptions must not take a front seat in shaping relations at a time when youth are in fact jumping to lead. Rather, societies around the globe are being afforded a remarkable chance of access to information to help shape more resilient understandings of how complicated realities are. In this context comes the project HADARA, which aims to help in part with building understanding among the rising youth of the 21st century.



Project Overview

The Egyptian population is projected to double over the next 30 years, while the millennial generation in the US is scheduled to compose 75% of the workforce by 2025. This means that the future leaders and decision-makers are growing up and being educated today. The problem is that even though information is all around us, there are very few reliable, credible and truly objective news sources available. Even more concerning, there are few-to-none that give a complete view of topics from all sides. As a result, youth either a) believe whatever source and materials they happen to find—usually to the detriment of their views of those outside their culture, or b) they become disenchanted with all of the sources and end up being influenced by hearsay because they are not doing their own reading.

We seek to build trust in our brand by providing every significant perspective on the international issues they care about through sourcing articles from various young and established thought leaders. We would then take the articles from graduate students, professors and seasoned experts, and stitch the best of those together in a way that allows a complete picture of an issue to be displayed.

Project Goals

The primary focus of HADARA is to provide 360 degree perspectives of global issues impacting the MENA region, in an easy to consume engaging format. By establishing a non-biased perspective, and presenting issues in a way that is comfortable and relatable for millennials+, we hope to better inform the future influencers—and in doing so, improve the perceptions Americans and Egyptians have of one another.

Expected Outcome

Through this project we hope to create a more informed generation that understands the complexities of the global issues around them. It is much harder to be biased against nations and people when you know what and why they make the choices they make. In providing a trusted source of information, we hope to increase positive feelings and decrease mistrust between cultures by targeting the rising leaders. By informing the future influencers, we believe we can affect policies and the views of a massive segment of both populations before they rise to power and begin taking action.

How the Project Contributes to the Foundation Mission

The Shafik Gabr Foundation aims at building bridges of understanding between the East and the West. In this department, comes the project HADARA to transcend the Fellows' shifted conceptions concerning the level of information and biases being presented to the public. This level of information presented has contributed in building huge misperceptions and misunderstandings within both societies. As a result, the Fellows are willing to pass on their experience to their community, within the political context, to ensure the full delivery of information on political decision-making processes and how influenced they are by societal givens. In ensuring this, the project will be inclined to present mere information rather than adopting standpoints to enhance its credibility and to allow a room for unbiased understandings. Thus, the project contributes to building understanding based on information rather than opinions.

VoteApp Civic Engagement Platform

The Challenge

Since 2011 and the rise of the so-called 'Arab Spring' Egypt has undergone unprecedented changes. Two revolutions and two constitutions later, Egypt has emerged from this tumultuous period as a young democracy. Access to social media and citizen-generated web content has become central to Egypt's young technologically-oriented population. Additionally, the emerging tech-based start-up scene in Egypt is burgeoning. With an estimated 75% of the population under 25 years old, a huge opportunity has arisen for Egypt to become a leading democratic state in the Middle East and North Africa (MENA). In October 2015, Egypt held its first fully democratic national parliamentary elections since the second revolution of June 30, 2013.

Egypt has moved quickly towards a fully democratic system of governance. However, there is a paucity of civil engagement and a lack of accompanying institutions to support this transition. Navigating politics in a young democracy with over 100 political parties can be an overwhelming process. As a result, electoral turnout, especially amongst the young, was rather low in the 2015 Parliamentary elections. The low turnout can, in part, be attributed to the lack of available information about candidates, elected officials and political parties. Furthermore, entrepreneurs in Egypt often suffer from the lack of access to experienced mentors and capital, both of which are crucial when it comes to turning a great idea into a great business. If Egypt is to continue to develop, it will need a healthy democracy and thriving small and medium-sized enterprises in the private sector.

Project Overview

The VoteApp is a civic engagement platform designed to educate voters about their political representatives. It will take the form of a web-based application that will help voters become more engaged in the democratic process in Egypt. By making information simple, accessible and informative, the platform will help users make more educated voting decisions.

A technology conference will be organized aiming to link the startup ecosystems of both Egypt and the United States. The conference is to be held in New York City, at which the VoteApp mobile application will be featured as tangible proof of the collaborative development effort between the East and the West, alongside startup demonstrations, industry speakers and investment seminars.

Project Goals

The vote application aims to allow users to:

- Discover candidates and elected officials, learn about their accomplishments, voting record and positions on issues
- Save favourite candidates onto their 'online ballot'
- Express public support by using support/trust buttons and share candidates' profiles on social media
- Explore political parties based on your views
- Compile campaigning material
- Allow politicians and candidates to more easily connect with their electorate

The East-West start-up conference aims to:

- Bring together start-ups and entrepreneurs from the East and West
- Provide an opportunity to discuss respective ecosystems
- Help start-ups from the East and West collaborate to overcome challenges
- Launch the VoteApp application
- Explore the investment climate in the West

Population Served

VoteApp's target population includes technologically-oriented citizens with access to a smartphone. Today, 30% of mobile phone users in Egypt are smartphone users.
