Fabrice Guerrier's Company Publishes New Book





Question 3: With the first visit of a Minister from the Israeli government to Egypt since 2011, do you think a natural gas partnership between Egypt and Israel can lead to regional peace and security?

Yes: 30% of respondents

No: 41% of respondents

I don't know: 29% of respondents

Question 4: Are you pleased with President Sisi's efforts to support the Coptic Christian community in Egypt?

More: 68% of respondents

Less: 16% of respondents

I don't know: 16% of respondents
