





Introduction by Shafik Gabr

I am very proud to celebrate the ten-year anniversary of the Shafik Gabr Foundation's *East-West: the Art of Dialogue* initiative.

This initiative was born in 2012, from a simple but alarming development. When I spoke to young Egyptians in provincial towns and talked about America they would say America is self-righteous, obnoxious, and if they disagree with you they will bomb you. On the other hand, when I spoke to Americans in the heartland of the US and I would mention Egypt they would say desert, terrorism, Islamophobia. These trends have been magnified by social media and other mass communication technologies — the very same tools that were meant to bring us together, created major misperceptions and animosity.

This concerned me a great deal, especially as I knew there was much more common ground, common interest and positive correlation between Americans and Egyptians than this worrying perception.



That is why I decided to create the *East-West: The Art of Dialogue* initiative and its flagship program, the annual Gabr Fellowship, in order to bring together young emerging leaders from America that have never been to Egypt together with young emerging leaders from Egypt that have never been to the US, to have first-hand experiences of the other, and to foster a deeper understanding between the two cultures. No virtual dialogue can replace genuine human, face-to-face interactions.

In this way, by connecting young leaders from Egypt and the United States — all with a shared vision of bridging divides — through an intensive exchange experience, they are better prepared to take the reins of leadership in their careers, communities, and beyond. During an intensive visit to Egypt and a similar one to the United States, these young leaders have the opportunity to interact, discuss, and debate with one another and with thought leaders across a variety of sectors including but not limited to politics, business, technology, art, history, and economics. After this, the Fellows are invited to execute joint action projects that the Foundation will support financially and administratively. By creating networks and engaging with the multitude of high-profile speakers, they can lay the foundation for ongoing cooperation that will ensure that human relationships remain central to our future.

We now have 142 Fellows across the US and Egypt, of whom I am immensely proud, and who are success stories in every field – art, politics, business, education, technology, and much more.

It is only by building bridges of understanding, investing in young leaders and finding common interest and mutual benefit will we be able to contribute to a better world tomorrow.

The Initiative

The mission of the Shafik Gabr Foundation's *East-West: The Art of Dialogue* initiative is to promote greater mutual understanding by building bridges between emerging leaders from the United States and Egypt. The initiative was established in 2012 in response to increasing tensions between the two countries, and sponsors and fosters exchanges between emerging leaders from a variety of fields from both cultures.

The annual Gabr Fellowship is the premier program of the *East-West: Art of the Dialogue* initiative at the Shafik Gabr Foundation. Each year, the Fellowship consists of twenty-four Fellows, with twelve Americans and twelve Egyptians, of which half are men and the other half women. Over the years, candidates from the United Kingdom, France, Lebanon, and Jordan have been invited to apply. The Fellows spend 10 days in Egypt, followed by 10 days in the United States, building enduring connections through rigorous discussions, cultural site visits, networking events, and hands-on activities. This is an intensive program consisting of high-level meetings and constant face-to-face dialogue with peers and distinguished speakers, engaging in deep discussions with key stakeholders from both countries in business, government, academia, religion, science, tech, finance and more.

Through seminars, working groups, discussions and workshops, the participants build leadership skills and an understanding of the 'other', while immersing themselves in complex policy matters and familiarizing themselves with the processes they are embedded in. This, along with various social events, cultural visits and activities, provides participants with an intimate glimpse into life on the other side of the Atlantic, something that we here at the Foundation believe is essential in developing the young leaders of tomorrow, who, as a result, will be dedicated to pursuing united, innovative solutions to the world's most pressing challenges.

The Gabr Fellows have acquired a greater understanding of both Egypt and the United States and the challenges faced by both communities. Having served as cultural as well as linguistic ambassadors to one another, they then return home to play the role of diplomat, introducing Egyptians and Americans to a people, a culture and a future never before explored in this way. Fellows are entrusted with unpacking the misperceptions and fears that have plagued the East-West relationship over the past years.

The experience does not end on the last day of the Fellowship, however. Upon their return to their communities, Fellows are tasked with implementing their creative action projects. The Fellows leverage their experience to transform their broader networks and beyond to develop meaningful initiatives that educate their colleagues, peers, family, and friends on the importance and power of intercultural dialogue. In addition, the Shafik Gabr Foundation hosts regular meetings of the Fellows with Chairman Shafik Gabr, in the United States and in Cairo, where the Fellows discuss global issues and well as share their news, current work developments and updates on their network groups, as well as their plans for the future.

The Gabr Fellows, empowered with new understanding and nuanced perspectives, become intercultural ambassadors. Together, they further advance the legacy of the Gabr Fellowship: an international cohort dedicated to pursuing cooperative, collective solutions to the most pressing challenges of today and tomorrow.


The Mohamed Shafik Gabr Foundation for Social Development (Egypt)

Bruce E. Mosler

As Chairman of Global Brokerage at Cushman & Wakefield Inc., Mr. Bruce Mosler advises major tenants and investors on strategic real estate matters, managing key client relationships on behalf of the firm, globally. Mr. Mosler served as President and CEO of Cushman & Wakefield from 2005–2010, leading the firm from \$800 million in sales to \$2.1 billion, and diversifying the company's revenue stream by 30 percent through expansion of the business in Europe and the Asia-Pacific region. Prior to this, Mr. Mosler was President of US Operations, and implemented a number of initiatives for the firm, including creating national leadership roles in industrial, retail and multifamily, and creating the Cushman & Wakefield Alliance, a first of its kind affiliate network of top independent real estate companies operating as a unified team with Cushman & Wakefield.



Mr. Mosler sits on numerous non-profit boards and most notably has directed much of his attention toward veteran and military issues. Mr. Mosler serves as Co-Chairman of the Intrepid Sea, Air and Space Museum, Chairman of the Shafik Gabr Foundation's Advisory Board, and Chairman of the Cushman & Wakefield's Veteran's Initiative. Mr. Mosler also serves on the Board of Governors of the Real Estate Board of New York and is a member of the Boards of the Team Rubicon, Navy League of the United States, New York State Troopers Foundation, Police Athletic League, Syracuse University's Institute for Veterans and Military Families and the Advisory Boards of the Navy SEAL Museum and Tufts University's Friends of Fletcher, among others.

Brigadier General (Retired) Tom Cosentino

Following an Army career that included numerous operational and strategic assignments over a 30-year span, the retired Army Brigadier General now serves as BENS (Business Executives for National Security) Chief Operating Officer, overseeing BENS' day-to-day operations while also improving outreach to and strategic dialogue with senior civilian and uniformed national security leaders. General Cosentino joined BENS in September 2015 following his last military assignment where he served as the 28th Commandant of the National War College.



Prior to assuming command of the National War College, General Cosentino served as Deputy Director for Political and Military Affairs, providing military advice to the Chairman of the Joint Chiefs of Staff and the Secretary of Defense.

He also served previously as the Deputy Commanding General for Regional Support, NATO Training Mission Afghanistan, and as the Chief of Strategy, Plans and Assessments for the Multi-National Security Transition Command in Iraq where he developed US plans to man, train, and equip over four thousand Iraqi Army and Police Forces.

General Cosentino earned a B.Sc. in Political Science at the University of the State of New York and holds Masters' Degrees in International Relations from Georgetown University and National Security and Strategic Studies from the Naval War College. He is also a PhD candidate in the Public Policy Program at the University of Maryland.

The Honorable Nick Rahall

Former Congressman Nick Rahall represented West Virginia's Third Congressional District for over three decades. He served as the Ranking Member on the House Transportation and Infrastructure Committee, and also served as Chairman of the House Natural Resources Committee from 2007 to 2011.

First elected in 1976, Congressman Rahall served nineteen terms in the US House of Representatives and is recognized as the youngest-elected, longest serving Member in the history of the House. As the longest serving member of the House Transportation and Infrastructure Committee, he worked to build and repair the nation's highways and bridges, improve and modernize airports, and provide critical water, sewer systems, and flood control projects throughout West Virginia and across the United States.



As Chairman of the Natural Resources Committee, Congressman Rahall worked to honor the Committee's charge of serving the natural environment, wild lands, scenic vistas, fish and wildlife, Native Americans, and the public interest.

Mohamed Ramzi Roshdi

Mr. Roshdi's professional career spans two decades across the private sector, academia, and international development. For over fifteen years, he has worked in a consulting and advisory capacity with leading multilateral organizations, including the World Bank, IFC, and the African Development Bank. His portfolio includes private and financial sector development, disruptive technologies, energy and human development across Africa, Europe, Asia and the Americas — in addition to working closely with senior management on business delivery and organizational efficiencies and restructuring.



Within the private sector, Mr. Roshdi has advised leading family offices and venture capital funds on investment strategies for the past decade. Prior to that, he was a co-founder of ReliaBid, one of the world's first e-commerce services companies.

He is a proud member of the advisory boards of several leading and emerging technology companies in the US and the Middle East. Mr. Roshdi received his Master's of Science Degree in Information Technology and his Bachelor's Degree in Business Administration from The George Washington University's School of Business.

M. Shafik Gabr is a renowned leader in international business, innovation, investment and one of the world's premier collectors of Orientalist art, and an accomplished philanthropist.

During his career, Gabr established over 25 companies plus three investment holding companies including ARTOC Group for Investment and Development which is a multidisciplined investment holding company with businesses in infrastructure, automotive, engineering, construction and real estate, over the past three years focusing on investment in technology and artificial intelligence.



Gabr is the Chairman and a founding member of Egypt's International Economic Forum (EIEF), member of the International Business Council of the World Economic Forum, Board Member of Stanhope Capital, International Chairman

of the Sadat Congressional Gold Medal Committee and Member of the Parliamentary Intelligence Security Forum. Gabr is Member of the Metropolitan Museum's International Council and serves on the Advisory Board of the Center for Financial Stability, Advisory Board of The Middle East Institute and the Global Advisory Council of the Mayo Clinic.

Gabr was previously the Chairman of COMESA (Common Market for East and South Africa) Business Council and a member of the Executive Board of the International Chamber of Commerce (Paris), and served on the advisory boards of Zurich Financial Services and The Paul H. Nitze School of Advanced International Studies (SAIS). Furthermore, Gabr was a founder of the American Chamber of Commerce in Egypt in 1982, serving as its first Egyptian President from 1995 until 1997. He was a Founding Member of the Wilson Global Advisory Council.

Gabr has been recognized globally for his efforts. In 2009 Mr. Gabr was presented with the Foreign Policy Association's (FPA) award for Corporate Responsibility. In June 2014 Gabr was awarded the Meridian Global Citizen Award and in November 2014 the Middle East Institute's Visionary Award. In March 2015 Gabr received the American University in Cairo's Global Impact Award in New York. In May 2016 Gabr was awarded the College of Mount Saint Vincent's Saint Vincent de Paul Award and the Drew University's Peacebuilder Award. In September 2017 Gabr received the Policy Direction and Leadership Award from the London Center for Policy Research. In 2022 Gabr received the Global Leadership Award from the University of Central Florida.

Through the Shafik Gabr Social Development Foundation, Gabr is helping to improve elementary-school education in Egypt, introducing students to arts and culture and promoting sports and physical fitness for youth. In the area of higher education, Gabr is a major supporter of the American University in Cairo. The Foundation also developed a free medical-care system by providing "Medical Caravans", for residents of underprivileged areas of Greater Cairo. The Foundation has its first Medical and Social Development Center in Mokattam, Cairo, offering free medical and health services. In 2012 Gabr established in the US the Shafik Gabr Foundation which supports educational and medical initiatives plus launched in November 2012 the 'East-West: The Art of Dialogue' initiative promoting exchanges between the US and Egypt with the purpose of cultural dialogue and bridge building. At present, the Foundation's Fellowship program has 142 Fellows.

Gabr holds a BA in Economics and Management from the American University in Cairo and an MA in Economics from the University of London.

Understand the differences; Act on the commonalities

The Challenge

The misinformation about the others, the lack of proper dialogue, and economic pressure that is leading to a massive misunderstanding problem, especially with the rise of fake news on social media spreading worldwide.



Project Overview

This project aims to counter misconceptions that Americans and Egyptians have about one another's culture through the use of performing arts and social media.

The Goal

To make all the different races in the US and Egypt find other cultures resonating with their experience, so they'd feel more connected to each other's society. The other expected outcome is to trigger a discussion and open dialogue on racial diversity in Egypt and to understand the culture of the different races in both American and Egyptian society.

Population served

The target audience would be young social media users aged between 14 and 35 in both the US and Egypt, of different racial backgrounds.

Expected outcome

- Increased understanding and appreciation of each other's cultures: soft power interactions, such as cultural exchanges and diplomacy, can help to increase understanding and appreciation of different cultures and ways of life.
- Improved relations between the two countries: Building bridges between American and Egyptian communities can help to improve relations between the two countries, potentially leading to increased cooperation and collaboration on a variety of issues.
- Increased economic and trade opportunities: Improved relations between the two countries could also lead to increased economic and trade opportunities, which could be beneficial for both sides.
- Greater political stability: Building bridges between American and Egyptian communities could also contribute to greater political stability in the region, as it could help to reduce tensions and conflicts between the two countries.

Project Milestones

Week 1

- Brainstorm and develop concept for music video
- Write treatment (detailed outline of the music video's story and visual elements)
- Determine budget and resources needed (e.g. crew, locations, props)

Project Overview

For one year, our team members will write articles, op-eds, and other written pieces with a focus on US-Egyptian relations or the Middle East at-large. When appropriate, the pieces will be submitted for publication at various outlets. At the end of the year, we will develop a compilation of the pieces into one journal to showcase the completed projects.

The Goal

To increase and de-silo cross regional understanding of how a culture and country play a role in the way we perceive and are affected by world events through collective journaling and discussions. Also, this journal is about bringing together the American and Egyptian viewpoints on global issues in different fields, through which it is possible to measure the indicators and factors affecting the formation of opinion and judgment on the Egyptian and American sides.

Population Served

The Journal will select common titles for discussion and analysis, to write periodically and consistent with the editorial standards and its policy of independence and credibility, the journal will target all those interested in international relations, including young people and specialists, as well as those who follow the affairs of the Middle East, the Arab world and American affairs from both countries.

Project Milestones

- Phase 1 (3 months): Initiate personal written commentary on geopolitical relations.
- Phase 2 (6 months): Develop in-house Socratic exchanges to support our developing viewpoints; Continue to write and foster reasoned expression.
- Phase 4 (3 months): Plan the development of the Journal.

Expected Outcomes

The immediate outcome is to increase understanding of everyday life and improve communication on the differences between geopolitical opportunity and threat. In the medium term each respective Fellow will scale written and oral skills between each other, community, and decision makers. The long-term outcome of this effort will spur a positive attitudinal and behavioral shift among the next generation of world leaders and produce a quality yearly Fellows publication.

Habibi Factor: Building bridges between humans

The Challenge

Project Overview

Target Audiences & Channels


We will target youth from US and Egypt who listen to podcasts on the most listened platforms applications in Egypt and the United States. We will use the social media platforms which are heavily used by both Egyptians and Americans to upload and promote the newly added episodes.

Project Milestones

- Phase 1: Two American and two Egyptian Fellows.
- Phase 2: Content drafting and choosing episodes topics.
- Phase 3: Launching the Podcast and releasing one episode every two months (a total of 6 episodes).

Furthering the Foundation's Mission

The project is intent on building bridges between Egyptians and Americans on a personal and human development levels. By sharing ideas between Egyptian and American Fellows through focusing on the human factor in the mutual relations between the two countries, we aim to narrow the gaps between the two societies on the mental and emotional levels.



Suez Canal Clean Emissions Rebate

The Challenge

The Suez Canal plays a vital role in Egyptian commerce and has tremendous geographic importance in world trade as one of the world's busiest shipping lanes and maritime choke points. According to the Suez Canal Authority (SCA)'s website, "2018–2019 showed the transit of approximately 19,000 vessels holding 1.2 billion tons of cargo onboard and revenues of USD \$6 billion." However, vessels pay approximately \$700,000 for one-way passage through the canal. Due to the high toll rates and global oil prices, commercial vessels are forgoing the shorter Suez



Canal route in favor of longer transit around southern Africa. Timing-wise, this is a major loss for Egypt, which in 2015 completed an \$8.5 billion expansion of the canal to reduce transit times and in 2022 suffered considerable international bad press with the blockage of the M/V Evergreen container ship. As the COVID-19 pandemic has made clear, faster shipping times are key in keeping supply chains consistent for providing essential supplies in an era when global shipping trade has more demand and strain than ever.

Project Overview

Strive to incentivize ship operators to transit the Suez Canal by offering clean emission rebates to ships in compliance with the UN's IMO 2020 Sulphur Oxide (SOx) and 2030 Tier III maritime regulations, regarding Nitrogen Oxides (NOx) emissions. By offering a financial green emissions transit rebate incentive, Egypt would be a progressive leader in the green initiative—in keeping with their COP27 ambitions, while driving more commerce and business to the country. Advertising and marketing the Suez's new rebates would diplomatically demonstrate that Egypt is a global leader contributing to cleaner environmental policy initiatives.

The Goal

Support the Suez Canal in its role as a main navigation vein to attract more ships commanding a larger percentage of global trade by negotiating a Suez Canal greener fuel emissions incentive for vessels offered through a discounted rebate program. Work closely and garner support from Egyptian diplomatic trade representatives, Suez Canal Authority (SCA), International Chamber of Shipping, the UN's International Maritime Organization (IMO) regarding emissions standards, and private sector partners. Upon arrival, vessels would need to provide Egyptian authorities proof of their green emission certificates from the standards agencies. By capitalizing on this initiative, it would serve to promote Egypt as a greener country, which would also enable Egypt to access other financial resources, such as green climate funds, that could compensate for any revenue reduction that may occur in the initial implementation phase.

Population Served

Incentivizing a rebate for cleaner emissions would promote greener standards within the global maritime industry and decrease international fuel waste and CO2 emissions. By lessening ships navigating around Africa,

fewer ship operators would use the more harmful Bunker-C fuel oil for long haul transits alternatively using low sulphur diesel oil (MDO/MGO) used along coast lines. Moreover, the reduction in sulphur content in ship's fuel oil would be healthier for Egyptian communities, as well as those along the Mediterranean and Red Sea coastlines. Local Egyptian farming and fishing industries would also benefit from the reduction in ocean acidification, which would lessen harm to their crops and aquatic species. The initiative would also preserve the banks of the canal, beaches, and corals in nearby tourist locations. Benefits would also extend far beyond Egyptian shorelines and be felt globally as more vessels are financially incentivized to acquire cleaner fuel emission systems, during their transit.

Project Milestones

- Phase 1: Vet project to key high level persons in the maritime industry and SCA for feedback.
- Phase 2: Contact key players in the maritime Classification Societies for feedback and guidance on emission standards for ships and certifications needed.
- Phase 3: Implementation
 - 1. Q1 2023: Identify the appropriate point of contacts/schedulers within high level offices of the Egyptian Government and begin reaching out to offices to schedule high level meetings. Research agencies capable of providing a professional visibility study.
 - 2. Q2 2023: Hold high level meetings with the chief persons responsible for discussion, consideration, and initial approval highlighting the benefits for the country. Determine if professional visibility study to be commissioned (how, when, by whom) depending on feedback from high level Egyptian authorities.
 - 3. Q3-Q4 2023: Negotiate the terms or possible rebate opportunities as needed. Discuss probability of new clean emissions rates to apply to vessels by Q1 or Q2 of 2024.
 - 4. Q1 2024: New transit clean emission transit rates to go into effect January 1st, 2024.
- Phase 4: Assist Egypt with publicity and promotion of new policy in Q1 2024 through international maritime publications.

Expected Outcomes

- Enhance the Suez Canal's strategic position as a main navigation hub and increase the Suez Canal's share of the global trade industry
- Drive more business and tourism to Egypt
- Global environmental impact by decreasing international fuel waste and CO2 emissions through incentivized shipping route through Suez Canal versus around Africa
- Encourage greener standards within the global maritime industry
- Improve waterways and agricultural communities along the Red Sea and Mediterranean
- Enable Egypt to access additional resources such as green climate funds throughout marketing this initiative as a green initiative

Furthering the Foundation's Mission

The project aligns with the Gabr Fellowship's goal of diplomacy and business leadership by highlighting Egypt's geographic and strategic importance in global trade, while bridging Eastern and Western relations through maritime commerce to tackle supply chain and global environmental concerns.

Women Artrepreneur Initiative

The Challenge

Throughout history, women have been famous figures of artistic representation... as the subject matter rather than the creator. When we look at history books, we see that women artists are almost non-existent. Even in modern-day, female creators remain marginalized. Overall, 96% of artworks sold at auctions are by male artists. In addition to the difficulties of being an "artrepreneur," women artisans face additional barriers in the entrepreneurship arena. Women entrepreneurs face a specific set of barriers given that they pursue entrepreneurship while often maintaining traditional roles of managing a home and family. The Women



Artrepreneur Initiative aims to connect women artisan entrepreneurs together to discuss specific issues and access business education to strengthen their businesses, advancing women's equity in the arts.

Project Overview

The Women Artrepreneur Initiative seeks to support female artist entrepreneurs in both the United States and Egypt by designing and launching an online course tailored to their needs. The course will tackle issues in entrepreneurship, such as launching their businesses, personal branding, and financial literacy. The course will offer an opportunity to explore different artistic perspectives from both the East and West. Lastly, each topic will touch on the unique challenges women face every day and how to break the glass ceiling in the art world. This will be done by incorporating different pedagogies such as expert guest lecturers, projects, peer learning, and more. By the end of the course, a new network of female artists will have the needed skills and network to launch and grow their brands.

The Goals

The Women Artrepreneur Initiative aims to achieve the following outcomes:

- Strengthen ties between Egyptian and American women entrepreneurs
- · Build an entrepreneurial ecosystem for artisans expanding beyond borders
- Educate female entrepreneurs with best business practices
- Provide a safe space for woman entrepreneurs to discuss the unique barriers faced by women
- · Increase the market share of female-produce art in the global art market

Population Served

The target population is female artists in both the US and Egypt who are interested in establishing or growing a business based on their craft. The initiative welcomes all ages, disciplines, and levels of experience.

Project Milestones

- Phase 1: Develop course curriculum & course schedule
- Phase 2: Obtain guest speakers for each course
- Phase 3: Marketing and recruitment of participants
- Phase 4: Pilot program launched

Expected Outcome

- To build the capacities of female artists in both Egypt and the US and prepare them for the industry's challenges
- To provide open-source online content tailored for female artists on entrepreneurship, art, mental health, and gender issues.
- To foster U.S.-Egypt cultural exchange by creating a network of women artist entrepreneurs.

Furthering the Foundation's Mission

The Women Artrepreneur Initiative furthers the Gabr Foundation's mission by creating a direct dialogue between the East and the West, connecting Egyptian and American women who are united in a common goal. The initiative aims to connect women artist entrepreneurs who likely have shared backgrounds as they navigate the common experience of gender, occupation, creativity, etc. Through this initiative, women will be able to enhance their skills and create a network full of opportunity that transcends borders. This course will allow them to connect, express themselves, share experiences, and learn more from one another. The exchange of cultural, professional, and personal resources between the two countries will create a pathway toward a more equitable future for Egyptian and American women alike.

Dr. Abdel Moenim Saied

Dr. Abdel Moneim Saied is the Chairman of the Board and CEO of Al-Masry Al-Youm Publishing House. He is the former Chairman of the Board, CEO, and Director of the Regional Center for Strategic Studies in Cairo and former President of Al-Ahram Center for Political & Strategic Studies. Dr. Saied was a Research Fellow at the Brookings Institute, Washington DC, and a Research Fellow at the Belfer Center for Science and International Affairs – Harvard University. Dr. Saied is also a Senior Fellow in the Crown Center for Middle East Studies at Brandeis University. He was a Political Advisor in the Amiri Diwan of Qatar, founded the Gulf Arab States Institute in Washington. Dr. Saied was also a Senator in the Egyptian Shoura Council. Dr. Saied has published books and articles on Arab relations with the regional and global orders, European integration, and the Arab-Israeli conflict. He has been a guest speaker in different conferences and Political programs.

Dr. Adel Adawy

Dr. Adel Adawy is the Economics and Political Science program director at Galala University, and also the founder of the Galala Youth Conferences series. He also lectures at The American University in Cairo, and the Egyptian Police Academy. He is the founder and executive director of the Cairo Center for African Studies think-tank. 

November 27, 2022–December 8, 2022 New York | Washington, DC

The U.S. portion of the Gabr Fellowship began in New York City with a cruise around Manhattan. 
